
AN ORDINANCE FOR THE VILLAGE OF LODI, MEDINA COUNTY, OHIO, DECLARING IT NECESSARY TO REPAIR OR INSTALL NEW SIDEWALKS, AND DECLARING THE SAME TO BE AN EMERGENCY.

WHEREAS, sidewalks in the Village are in a state of disrepair or no sidewalks; and


WHEREAS, the areas in need of repair or installation of new, and the parties owning the parcels of land abutting the sidewalks, are identified in **EXHIBIT A**, which is attached hereto and fully incorporated herein by reference;

NOW THEREFORE, BE IT ORDAINED OF THE COUNCIL of the Village of Lodi, Medina County, Ohio that:

1. Council finds and determines that the sidewalks listed in Exhibit A are in need of repair or installation of new; and, therefore, it is necessary to repair, replace or install new sidewalks according to the plans and specifications on file in the Office of the Clerk of the Village of Lodi.
2. The Clerk of Council is hereby authorized and instructed to serve Notice of the passage of this Ordinance on the owners of the lots and lands abutting on the sidewalks identified in Exhibit A herein.
3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate passage of which is necessary for the benefit of and the health and safety of the Village of Lodi and its inhabitants in order to avoid injury, and therefore this ordinance shall take effect at the earliest time permitted by law.
