Ordinance No. 2674-06

Passed May 15, 2006

AN ORDINANCE OF THE VILLAGE OF LODI, MEDINA COUNTY, OHIO AUTHORIZING THE MAYOR AND THE CLERK TO ENTER INTO A CONTRACT WITH G&O SPRAY SERVICE FOR MOSQUITO CONTROL, AND DECLARING AN EMERGENCY.

WHEREAS, Council of the Village of Lodi wishes to enter into a contract to provide mosquito control within the Village for the year 2006; and


WHEREAS, Council of the Village of Lodi has sought quotes for such mosquito control services; and

WHEREAS, G&O Spray Service has provided the most desirable quote to Council for such services and Council wishes to authorize the Mayor and the Clerk to enter into a contract with G&O Spray Service to provide mosquito control within the Village for the year 2006.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LODI, MEDINA COUNTY, OHIO that:

1. The Mayor and the Clerk are authorized to enter into a contract with G&O Spray Service for the provision of mosquito control service for the year 2006. The price of each application shall not exceed the sum of \$515.00 unless the surcharge is added pursuant to the contract. Council shall later determine the amount of applications to be provided in the year 2006. Said contract is attached hereto and marked Exhibit "A".
2. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the inhabitants of the Village of Lodi; the specific reason for the emergency being the need to immediately provide mosquito control services within the Village, and therefore this ordinance shall take effect at the earliest time permitted by law.



I Bob Moorhead, doing business as G&O Spray Service Inc., do hereby enter into a mosquito control agreement for the year 2006 with the village of Lodi, Ohio.


G&O Spray Service is licensed to conduct mosquito control in the state of Ohio. My custom applicators license is enclosed with this agreement. G&O Spray Service is insured by a business liability policy issued by Nationwide Ins. Co. and a paid premium for Workers Compensation is also enclosed with this agreement.

G&O Spray Service will provide all materials, labor, and equipment to be used for the control project.

G&O Spray Service will use the material Mosquitomist One which is approved by the EPA for adult mosquito control in areas such as your village. All applications will be made in the evening or nighttime hours. I recommend applications once every 2 weeks when mosquitoes become active in the village. It will be the decision of village of Lodi as to how often and when applications will begin.

The price of each application will be five hundred fifteen dollars (\$515.00) and billed to the village each month. A surcharge will be added to your statement if and when the price of fuel should exceed \$2.999 per gallon.
