Ordinance No. 2703-06

AN ORDINANCE OF THE VILLAGE OF LODI, MEDINA COUNTY, OHIO AMENDING ORDINANCE NO. 2655-06, AS AMENDED FIXING THE SALARIES AND WAGES OF EMPLOYEES OF THE VILLAGE OF LODI AND DECLARING THE SAME TO BE AN EMERGENCY.

WHEREAS, Council previously adopted a pay Ordinance which became effective February 5, 2006; and

WHEREAS, Council now desires to amend Section II of the Ordinance regarding Fire and Rescue Department Chiefs.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LODI, MEDINA COUNTY, OHIO THAT:

1. The current pay Ordinance as referenced above is hereby modified as follows:

SECTION II: FIRE AND RESCUE DEPARTMENT

- A. Fire Chief \$2,187.27 per year payable monthly.
- B. Rescue Squad Chief \$2,187.27 per year payable monthly.
- C. (1) Assistant Fire Chief \$1,591.18 per year payable monthly.
- D. (1) Assistant Rescue Chief \$1,591.18 per year payable monthly.
- E. Fire and Rescue Personnel \$7.00 per hour for Fire & Rescue calls.

The Fire and Rescue Personnel shall be compensated at a rate of \$7.00 per hour for each Fire and Rescue meeting, Fire and Rescue practice sessions, and administrative duties assigned by a Chief or Assistant Chief of the Department. Chiefs and Assistant Chiefs shall not be compensated for administrative duties at the hourly rate in addition to their regular yearly salary but shall be compensated for Fire and Rescue calls and attendance at Fire and Rescue meetings and practices.

The total hours for Fire and Rescue meetings, Fire and Rescue practice sessions and Fire and Rescue administrative duties assigned by a Chief or Assistant Chief shall not exceed 3500 hours for the entire Fire and Rescue Department compensated on an hourly basis.

Fire and Rescue Personnel shall be paid monthly at the end of the month, rather than bi-weekly. If a member of the Fire and Rescue Department has worked a low amount of hours during a month resulting in a negative monthly paycheck after deductions, that member will not receive a paycheck for that month but will be compensated in the month or months following when the paycheck results in a positive amount due to the member of the Fire and Rescue Department.

The same work period is hereby established for the Fire and Rescue Personnel as established for the Police Department as set forth in Section I of the pay ordinance. All overtime provisions as set forth in Section I shall apply to the Fire and Rescue Department.

On a monthly basis, and prior to the monthly council meeting, the Fire Chief and Rescue Chief shall provide Council and the Mayor with an activity report for the Fire Department and Rescue Squad for all activity for the preceding month. The report shall be given to the Clerk/Treasurer for distribution to the Mayor and Council Members.


Fire and Rescue Personnel may request leave from the Chief of the Department for approval by the Chief of the Department. All requests for leave should be in writing on a form which shall kept by the Clerk/Treasurer in the employee's personnel file.


Should a member of the Fire and Rescue Department take leave or terminate employment for any reason other than for sick leave as defined in this Ordinance, and that employee is under contract to the Village as a result of the Village paying for training expenses of the employee, the employee must immediately reimburse the Village for said training expenses pursuant to the terms of the contract.


2. This Amendment to the 2006 Payroll Ordinance shall be retroactive to February 5, 2006.
3. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety and welfare of the Village of Lodi and its inhabitants; the specific reason for the emergency being the immediate need to correct vagueness in the pay ordinance regarding Fire and Rescue personnel, and therefore this Ordinance shall take effect immediately upon its passage.
