AN ORDINANCE OF THE VILLAGE OF LODI, MEDINA COUNTY, OHIO, AUTHORIZING THE MAYOR AND CLERK TO ENTER INTO A CONTRACT FOR CLEANING SERVICES AND REPLACEMENT DECLARING AN EMERGENCY.


WHEREAS, Council deems it advisable to continue to hire an outside independent contractor for the services of cleaning of Village offices; and

WHEREAS, Council has reviewed the contract which is attached hereto and incorporated herein by reference and finds the same to be suitable and appropriate for Village purposes.


NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Lodi, Medina County, Ohio that:


1. The Mayor and the Clerk are hereby authorized and directed to enter into a contract with Andrews, Inc. all in accordance with the terms and conditions set forth in the contract attached hereto.
2. The Contractor named in the contract attached hereto shall perform the services for the Village under the direction of the Clerk/Treasurer of the Village. The Clerk/Treasurer is hereby authorized to use the services of the contractor for a maximum of 600 hours for a period commencing with the effective date of this Ordinance and ending October 16, 2007.
3. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace, health, safety and welfare of the Village of Lodi and its inhabitants; the specific reason for the emergency being the need to continue the services of the aforesaid Contractor in order to maintain clean and sanitary conditions for Village employees and the general public and therefore this Ordinance shall take effect immediately upon its passage.

CONTRACT

THIS AGREEMENT, entered into this 16th day of October, 2006, by and between the Village of Lodi, hereinafter referred to as "Village" and Andrews, Inc., hereinafter referred to as "Contractor".

WITNESSETH:


WHEREAS, the Village desires to enter into a contract for cleaning services for its offices located at 108 Ainsworth Street, Lodi, Ohio and the Contractor is engaged in the business of office cleaning.


NOW THEREFORE, it is mutually agreed by and between the parties hereto that the Contractor will undertake the general cleaning and maintenance of the premises commonly known as 108 and 110 Ainsworth Street, Lodi, Ohio. The work shall be performed on a regular weekly basis at the call and direction of the Clerk/Treasurer who shall determine the scope and extent of the work. The Contractor shall be compensated by the Village at a rate of \$10.50 per hour. Payment shall be made to the Contractor on a monthly basis. The effective date of this contract shall be October 16, 2006 and shall be in effect until October 15, 2007. Contractor shall maintain liability insurance in effect during the term of this Agreement and shall provide Village with a certificate of insurance within thirty (30) days of this Agreement.

Either party to this Agreement may terminate this Agreement prior to the end of the term with thirty (30) days written notice to the other party.


